There is \$30,000 in the reserve funds for a car and he would like to use it for this purchase. He is getting pricings around \$29,000. Savings of \$1000.00, motion by Trustee Smith- all ayes

MEGA- (Municipal Electric & Gas Alliance)

They did a presentation about the company's Community Choice Aggregation program. Ms. Gava talked about how the energy aggregator is looking to lower energy costs for residents if the village becomes part of a consortium with other municipalities in the state.

The Village currently has four openings at this time. They are Recreation Director, MEO, Superintendent of Streets, and Clerk Treasurer. We will have the postings in the Cortland Standard and on the Village website.

Fireman Field Days are from June  $9^{th}-11^{th}$ . Tim Maxson would like someone to be in the parade from the Office.

Declaration of Independence- The 21<sup>st</sup> annual public reading of the United Sates Declaration of Independence will take place on Monday, July 4<sup>th</sup> at 10:00 at the Center for the Arts.

Holiday in Homer will take place on July 16<sup>th</sup> on the Village Green.

Trustee Clune spoke about the Code Book Update. Mayor Suits mentioned maybe adding Solar panels, Drones, used car lots in B2.

Micro Enterprise will meet on June 16<sup>th</sup> at 7:00 pm at the Community Building. It's for small businesses with 1-5 employees.

Mike Harter spoke on behalf of Larry Barber about the Pump Station on Clinton St. They have to go there a least 3 times a day to reset it. We will look at some bids and see what funds we have.

Bob Johnson asked about the wires in front of the fire house for the Alarm System. He heard they are high voltage. Someone mentioned that they have been there since 1940s.
