#### December 2018 Monthly report

Date: December 27, 2018

For the time period: 11/26/18 - 12/26/18

Mayor and members of the board.

#### **Patrol Monthly Activities:**

Please refer to the attached detailed reports for last month. There were a total of 316 calls for service during the month of December. Officers had a total of 5 Penal Law arrests which consisted of 2 misdemeanors and 3 felonies. They conducted a total of 39 vehicle and traffic stops, which resulted in 13 traffic tickets being issued, 1 arrest for the unclassified misdemeanor of Aggravated Unlicensed Operation in the 1<sup>st</sup> and 1 for Driving While Intoxicated. They also investigated 13 motor vehicle collisions, 1 of which involved injuries.

Notable investigations or incidents during the month of December: a burglary investigation and subsequent arrest of a known suspect entering an unlocked residence and stealing items from within; a verbal domestic in a moving motor vehicle and when it was stopped by patrol it was determined that the driver was in possession of a controlled substance; a traffic stop on North-West St that resulted in the arrest of the operator for driving while intoxicated and aggravated unlicensed operation and a larceny investigation at a village business where an employee was arrested for stealing currency and products along with falsifying the businesses business records while doing so.

#### **School Officers Reports:**

Please refer to the attached detailed school resource officer's report for October. There were a total of 362 incidents that the resource officers were involved in during the month of November.

#### Recent updates:

Security cameras updates: No issues with the current cameras during the month of December. I met with a representative from Beard Electric regarding the possibility of adding cameras at the police department and the town hall. The representative is preparing a quote.

Patrol vehicles updates: No issues with the patrol vehicles regarding maintenance.

Bike patrol updates: The bikes have been stored for the winter months.

Grant updates: No updates.

#### Miscellaneous and Events:

In-service training for the officers was completed during the month of December. The training consisted of legal and policy updates as well as Taser recertification training.

During the month of December we completed the required lockdown drills at each of the schools for 2018. Village officers and school resource officers were assisted completing the drills by officers from the Cortland County Sheriff's Office and troopers from the New York State Police. Although village officers and school resource officers are more than capable of conducting the drills with school staff this afforded outside agencies to learn the layout of the schools as well as the opportunity to become familiar with the school resource officers and school administrators. There was positive feedback from the school administrators and staff for including the outside agencies.

On December 4, 2018, I attended a planning meeting in Binghamton regarding the Department of Defense Medical Professional's (US Military's) Innovative Readiness Training (IRT). The following day, December 5, 2018 military personnel came to the intermediate school where they did a site review / inspection.

On December 19, 2018, we hosted a safety presentation for village residents at the town hall. The safety presentation focused on burglaries, robberies and identity theft (scams or frauds) prevention.

Winterfest 2019 will be on January 25<sup>th</sup> and January 26<sup>th</sup>. Several hundred people typically attend this event. We will be assisting the Winterfest Parade on January 26<sup>th</sup> at 10:15am. Officer Howell will be fingerprinting children free of charge in the elementary school cafeteria after the conclusion of the parade.

In conclusion, Officer F. "Jay" Forbes completed the required field training and will begin covering shifts on a part time basis. Officer Forbes graduated from the Cazenovia Police Academy in June of 2018 and after additional training (firearms and defensive tactics) provided by the Cortland County Sheriff's Office began the field training program, which consisted of 160 hours working with field training officers. In addition to his duties as a part time police officer, he will continue as the departmental chaplain. He is not only an asset to the police department but to the village.

The SRO's facilitate assistance for all through the use of police department, school and community resources. The SRO's also conduct investigations, assist in certain student/parent meetings, phone consults, partner agency meetings, referrals, informal counseling, providing assistance to school officials and assistance to other police officers and agencies in regards to students or school issues and property.
