Frank H. Suits, Sr., Applicant/Frank H. Sr. & Elizabeth Suits, Reputed Owners - 106 Clinton Street - TM #66.40-01-01.111 AND Genevieve Suits, Reputed Owner - 18 Balmoral Way - TM #66.40-01-01.120 - Lot Line Adjustment

Chairman Irish recognized Attorney Fran Casullo, representing the applicant who was seeking approval to sell 2.82± A. of this 12.40± A. parcel to the adjacent property owner, Genevieve Suits, constituting a Lot Line Adjustment, all as shown on the map accompanying the application. What is indicated on the map as Lot 1 and Lot 2 would be consolidated.

Chairman Irish acknowledged receipt of an 8/16/19 memo from Cortland County Planning stating that the request was technically adequate and had no State- or County-wide impact; therefore, it was being returned to the Village for local determination.
