January 2021 Monthly report

**Date: January 28, 2021** 

For the time period: 12/26/20 - 01/26/21

Mayor and members of the board,

#### Patrol Monthly Activities:

Please refer to the attached detailed reports for last month. There were a total of 461 calls for service during the month of January. Officers made 4 unclassified misdemeanor arrests, 3 for aggravated unlicensed operation in the 3<sup>rd</sup> degree and 1 for operating a motor vehicle while registration is suspended or revoked. Officers also made 1 DWI arrest and conducted 74 vehicle and traffic stops where they issued 34 traffic tickets. They also responded to 13 motor vehicle collisions, 10 of which involved property damage only.

Notable investigations or incidents during the month of January: 2 car motor vehicle accident where an intoxicated driver struck a parked motor vehicle; a disorderly conduct complaint which resulted in an individual being arrested on a bench warrant out of Binghamton Police Department; a traffic complaint where a commercial motor vehicle became stuck exiting a business and obstructed traffic at a major intersection (NYSP Commercial Motor Vehicle Unit assisted and the vehicle was take out of service for logbook violations and a criminal mischief complaint where a vehicle was intentionally damaged;

#### **School Officers Reports:**

Please refer to the attached detailed school resource officer's report for the month of January 2021. There were a total of 329 incidents that the resource officers were involved in during the month.

#### Recent updates:

Security cameras updates: No issues with the security cameras at any of the municipal buildings or parks. However, as indicated in the December report, the camera lens covers need to be cleaned. Microfiber towels have been purchased and they will be cleaned by the DPW when time permits.

Patrol vehicle updates: No issues with the patrol vehicles other than vehicle 126. An appointment was made with Dovi Motors Inc. and it was determined to be issues with the spark plugs and a fuel sending unit.

Grant updates: as weather permitted, we utilized some of the 2021 traffic safety grant we were awarded by the governor's traffic safety committee for police traffic services program in 2021.

#### Miscellaneous and Events:

With Covid-19 cases increasing, officers are continually reminded to wear masks when in public and to clean the patrol vehicles before and after their shifts. As of this date all officers and staff at the police department have been healthy with no positive tests for the virus. Also, almost all the officers (full-time and part-time) have received the first vaccine but there were some that opted not to receive it.

Local courts have continually postponed in person proceedings due to Covid-19 concerns and are conducting the proceedings virtually.

Officers attended in-service at the Cortland Armory on December 28, 2020, December 29, 2020 and December 30, 2020. The in-service consisted of use of force policy review, ASP baton, pepper spray, taser recertification, excited delirium, positional asphyxia, and de-escalation techniques. The topics were presented by instructors from the village police department.

Departmental firearms / active shooter instructors have been meeting with outside law enforcement agencies to plan the annual active shooter training. Due to Covid-19 concerns this training will be in March and April of this year with smaller groups of officers attending.

Due to limited seating and a large response from agencies, I was once again not accepted to attend the New York State Division of Criminal Justice Services train the trainer course in Principled Policing scheduled between the dates of January 12<sup>th</sup> through the 15<sup>th</sup> in Binghamton. The state is anticipating offering this course at various locations around state in the future. This training focuses on the way police interact with the public and how these interactions influence crime rates and the public's view of police and willingness to obey the law. Practicing procedural justice can have a significant impact on compliance, cooperation, public safety and officer safety.

Along with the Principled Policing training, I have scheduled all the full-time officers to attend First Responders Disability Awareness Training. This course includes definitions of disabilities specific to law enforcement, how to recognize-identify-approach-interaction-response model, victimization/abuse, the Americans with Disabilities Act, service animals, de-escalation strategies, and current trends and topics. This training will be held virtually and will be in March. This training will be beneficial to the officers.

On January 20, 2021, I attended a virtual New Justice Conflict Resolution Services meeting. As indicated in the December report, I became a board member with this organization, which offers mediation, arbitration, and process facilitation services. There is a possibility that someone from this organization will conduct a presentation during a police department in-service during 2021 so that officers are aware of the services that are offered.

During January 2021, the yearly evaluations for 2020 were completed and I have been in the process of reviewing them with each individual officers. The evaluations are not a form of discipline, but area form of training so that the residents of the village are better served.

On February 1, 2021, was the Homer Police Department's annual awards presentation will be at TLC Ambulance Services. During the presentation three Homer Police Officers and an Investigator for the New York State People received the departmental life-saving awards for their actions during 2020. Also, a former Homer Police Officer received the departmental distinguished service award. TLC Ambulance Services will also be presenting awards to officers and their employees.

So that we are in compliance with the governor's executive order number 203, the community forum or presentation regarding the operations of the police department will be held virtually on February 15, 2021 at 6pm. The village office has also began mailing questionnaires to residents and business owners so that we can aid in evaluating the overall operations of the police department. The questionnaires are due back to the village office no later than March 1, 2021. A comprehensive plan must be approved by April 1, 2021.

In conclusion, there has been a slight increase again of phone scams where the unknown caller purports to be someone from the Social Security Administration, the Internal Revenue Service or other governmental institutions. Residents are reminded not to provide any pedigree information over the phone or by the mail.
