PUBLIC HEARING #1: The Village of Homer is considering a local law to opt out of on-site consumption establishments from locating within the VILLAGE of HOMER in CORTLAND COUNTY, NEW YORK.

Local Law No. 1 of 2021

A LOCAL LAW opting out of on-site consumption establishments from locating within the VILLAGE of HOMER in CORTLAND COUNTY, NEW YORK

Be it enacted by the Board of Trustees of the VILLAGE OF HOMER as follows: The VILLAGE of HOMER expressly opts out of licensing and authorizing establishments that allow the on-site consumption of any forms of recreational cannabis.

Section 1. Opting out of allowing establishing that allow on-site consumption of recreational cannabis

The Village of Homer, NY hereby opts-out of licensing and establishing on-site cannabis consumption establishments within the Village.

Section 2. Permissive Referendum as Per NYS Cannabis Law Section 131

This local law is subject to permissive referendum in accordance with Cannabis Law Section 131.

Section 3. Separability

If any part or provision of this Local Law or the application thereof to any person or circumstance be adjudged invalid by any court of competent jurisdiction, such judgment shall be confined in its operation to the part or provision or application directly involved in the controversy in which such judgment shall have been rendered and shall not affect or impair the validity of the remainder of this Local Law or the application thereof to other persons or circumstances, and the BOARD OF TRUSTEES of the VILLAGE of HOMER hereby declares that it would have passed this Local Law or the remainder thereof had such invalid application or invalid provision been apparent.

Section 4. Effective Date

This Local Law shall take within thirty days after its adoption or until approved by the affirmative of a majority of the qualified electors of the village in accordance with sections 9 and 27 of the Municipal Home Rule Law.
