A LOCAL LAW AMENDING HOMER CODE Section 210-48: Vehicles and Traffic OF THE CODE OF THE VILLAGE of HOMER in CORTLAND COUNTY, NEW YORK

Be it enacted by the Board of Trustees of the VILLAGE OF HOMER as follows: The VILLAGE of HOMER Code Section 210-48 is hereby amended by this Local Law to repeal these provisions as follows:

<u>Section 1.</u> Repealing the parking restrictions that exist in this section in regard to Meadow Drive and South William Street

**WATER and SEWER** – Report was received as submitted. Mayor McCabe reads the report. Water and Sewer Superintendent Barber noted the mapping is being transferred to the new software. **Motion** to accept the report as submitted by Trustee Clune, Seconded by Trustee Slack- **all**

## **NEW BUSINESS:**

Presentation was done by Byrne Dairy. The package submitted is for a zone change on Route 281 and 90. 3 parcels are under contract for ~2.84 acres. Vacant parcel is Zone B1. 36 West Street is partially zoned B2 and R2. 66 West Street is R2. Met with the neighbors for open dialog and to present site plan. Currently I've contacted NYS DOT, did a traffic study, asked for concentrations on school district. Goal is to better intersection. Dante noted at this stage, the zoning change should be referred to Planning and County for recommendations to change the zoning and then a public hearing would be held. **Motion** by Trustee Clune to refer plan to County and Village Planning Board for referrals- **all ayes.** 

The Village Clerk read the resolution regarding Barton & Loguidice (B&L). Taylor Bowtar and Jackie Knovac from B&L spoke on design and specification for project. There was \$1.7 million contract with grant and loans. The resolution approves advertising for the bids of contract. Bids should be opened mid-March with approval by the Board subsequently. Anticipating a four-month construction period, which will include 220 manholes to fix and then liners in the sewer main, and then 25 feet of sewer main that has to be dug up and replaced also in the contract. The amendment is for B&L's time. DOT has requested an environmental site assessment, which is anticipated to cost \$5,000. Based on current budget and the amendments including the B&L fee, there is still \$221,000 available for contingency. Mayor McCabe asked

if B&L vets out the contractors. B&L representatives answered all contractors are vetted. **Motion** by Trustee Daley, seconded by Clune to accept the amendment as presented for the Sewer Project- all ayes.

Dante presented three contracts to be approved for the Route 11 properties. IDA, Harter, and Contento were presented. **Motion** to approve purchase agreements and authorize the Mayor to sign these by Trustee Daley, Seconded by Trustee Slack- **all ayes.** 

Village Treasurer DiGennaro presented the proposed budget adjustments. **Motion** to accept the budget adjustments as presented by Trustee Finkbeiner, Seconded by Trustee Slackall ayes.

Village Treasurer presented a proposal to purchase various items for the water and sewer department. **Motion** to approve the purchase of items and reserve funds for the overhead doors and the sewage door by Trustee Daley, Seconded by Trustee Finkbeiner- **all ayes.**

Trustee Daley noted a taxpayer sent an email questioning the lack of food program for teens. Mayor McCabe believed this was a great idea and asked Trustee Daley to take charge of the project.

Trustee Clune noted he attended the town meeting. The Town is reviewing the lighting out back of this building, which some residents have issues as it is so bright. The Town is looking to get shields.
