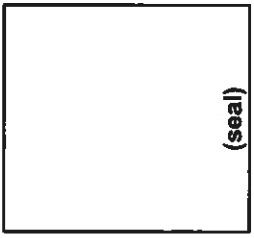

Resolution Establishing a Standard Work Day for Elected Officials Participating in the New York State and Local Retirement System

Whereas, New York State Employees' Retirement System Rule 315.4 requires reporting to the Retirement System, on a form prepared by the State Retirement System, with respect to work days for certain elected officials who are members of the Retirement System and who are being reported for service credit and for whom the Village does not maintain time records; and

Whereas, Rule 315.4(b) requires that the Village Board of Trustees adopt a resolution establishing a standard work day for each such elected or appointed office or position if the holder of that office or position is a member of the Retirement System for whom service credit is being reported.
