The monthly fire statistics, for your review, follow this report.

We had 56 calls in the month of March. The majority of the calls that we made were medical calls. Good intent calls where we were cancelled before we arrived came in second and motor vehicle accidents came in third.

We had a reprieve from the flooding calls in the month of March. Hopefully the April showers will not be as bad as past years. I believe we had more than our fair share of flooding.

March also gave us the start of Daylight Savings Time. In the past we would say, "Change your clocks, change your batteries." With the requirement of sealed batteries, changing them is almost a thing of the past. In fact, if your battery comes out, the detector is probably older than ten years.

We still use this time of year to educate people on smoke detectors. Check the date. If it's older than ten years it should be replaced. There should be a smoke detector in every room that someone sleeps in. It should be placed within three feet of the door. And hopefully, everyone in your home sleeps with the door closed. This will insure that it wakes you up. There should be one in the hall outside of the bedroom area. This will alert everyone before the smoke makes it into your bedroom. Wake the lightest sleeper and hope they can be loud enough to wake everyone else. There should be a smoke detector on every floor of the home.

This month's Department training was SCBA use and smoke behavior. SCBA stands for Self-Contained Breathing Apparatus. Just like SCUBA without the underwater part. These are the

air packs that we wear. We also had all 39 of our air-packs get their annual certification in

March.

Last month we had a Spaghetti Supper fundraiser event. It was pickup only and something we

haven't done in recent years. It wasn't as much of a success as we hoped but it was something

new and different for us to try. If anyone has any ideas for us to try as a Department fundraiser,

stop in and let us know. And while you're here, feel free to pick up an application. We love

people with ideas.

At the end of the month we had some visitors from Homer Scouts Pack 1. They took a tour of

the station and we discussed fire prevention and how firefighters serve their community. It is

nice to have visitors during this post pandemic time.

And on that note; April brings our big statewide recruitment weekend. It will be April 23rd &

24th at the station. Stop by and check out the station and equipment. It takes many people to





Date: March 28, 2022

Mayor and members of the board,

Patrol Monthly Activities:

Please refer to the attached detailed reports for last month. There were a total of 349 calls for service during the month of March. Officers made 3 unclassified misdemeanor arrests for aggravated unlicensed operating in the 3rd degree, 1 unclassified misdemeanor arrests for aggravated unlicensed operating in the 2nd degree, 1 unclassified misdemeanor arrest for operating with a suspended registration, 1 violation arrest and a bench warrant arrest. Officers conducted 85 vehicle and traffic stops and issued 52 traffic tickets. They also responded to 9 motor vehicle collisions all but 1 involved property damage.

Notable investigations or incidents during the month of March: a criminal mischief investigation involving a door to a residence; a larceny of a package from a hallway of an apartment building; a larceny arrest involving an employee of a village business and 2 separate larcenies where it was determined after investigation property was not stolen.

School Officers Reports:

Please refer to the attached detailed school resource officer's report for the month of March 2022. There were a total of 911 incidents that the resource officers were involved in during the month of March.

Recent updates:

Security cameras updates: no issues with the security cameras at any of the municipal buildings or parks.

Patrol vehicle updates: new tires were purchased for patrol vehicle 125. No other issues with the other patrol vehicles.

Grant updates: due to the inclement weather during March, we only used the traffic safety grant funding on one day. In April there are some optional traffic safety campaigns that are grant related that we will be participating in The Distracted Driving campaign: U Drive. U Text. U Pay, will be between April 4th and April 11th and the No Empty Chair campaign will be between April 25th and April 29th. The No Empty Chair campaign is in an effort to raise awareness about the dangers of unsafe driving with the goal to have no empty seats at proms or graduation ceremonies.

Miscellaneous and Events:

During the month of March there were no covid concerns involving the officers.

The yearly evaluations were completed in February. The evaluations have been reviewed with all the full-time officer, the school resource officers and the part-time officers that work on a regualr basis. There are a few part-time officers that still need to receive their yearly evaluations.

On February 26, 2022, the Homer Trojans Wrestling Team competed in the state championships at the MVP Arena in Albany, NY. Homer Wrestlers Talan Hubbard, won the 110 LB NYS championship and Sam Sorenson, won the 215 LB NYS championship. This was the first time a Homer wrestler has won a New York State championship since 1967. This agency, the Homer Fire Department and the Cortlandville Fire Department gave the champs and the team a victory escort through the village when they returned on February 27, 2022.

On March 1, 2022, and March 2, 2022, Officer Cresap and I attended a Child Abduction Response and Investigation training at the Broome County Police Academy. This two-day training was presented by the New York State Missing Persons Clearinghouse, and it based on the FBI's Child Abduction Response Plan.

On March 5, 2022, Homer Elks Lodge #2506 had their "Winter Celebration". As part of their celebration the lodge had their annual chicken wing eating contest that they usually have during Winterfest in January, but it was postponed due to Covid. I competed in the contest and took 3rd place. The contest raised over \$500 towards Cerebral Palsy.

On March 15, 2022, I met with SUNY Cortland University Police Chief DePaull. We have agreed on some tentative dates in April, May and June to co-host Principled Policing – Procedural Justice I for officers from both agencies as well as outside agencies. We will be submitting a curriculum to New York State Division of Criminal Justice Services for approval.

I have registered with the National Night Out organization and obtained permission from the First Religious Society to host a National Night Out event here in the village this year. This event is held every year on the first Tuesday in August across the United States and Canada. Residents, organizations, and officers from police departments come together to enhance the relationships. It is a great way to bring everyone together for a positive cause. This year it will be held on August 2, 2022. On March 15, 2022, I met with the village treasurer, Tanya DiGennaro, and the village recreation director Zachary Pollak to begin organizing this event.

As indicated in the February report, Officer Cresap attended forensic interview training. She also completed virtual training on March 16, 2022, entitled "First Response to Child Abuse Allegations". She is scheduled to attend a Crimes Against Children Seminar at the New York State Police Academy between March 28, 2022, and April 1, 2022.

I would like to recognize and congratulate Officer Cresap on earning her Associates Degree in Criminal Justice from Mohawk Valley Community College. She earned her degree after starting her career with the police department and while raising a family

Recruit Officer Jordan Cowen is doing well at the Syracuse Regional Police Academy, which started on February 28, 2022. As part of their training at the Syracuse Police Academy, police recruits volunteer four hours each month in their respective communities during the academy. On March 21, 2022, Recruit Officer Cowen, who played baseball in high school as well as in college and Mansfield University, assisted the Homer Varsity Baseball Team as they hosted an indoor clinic at the Homer High School gym for the Homer Little players.

With the weather becoming nicer, there has been an increase in juvenile related incidents in the area of library and the village green. On March 24, 2022, I met with representatives from the library and Trustee Clune to formulate ideas and or plans to prevent any incidents. Officers have been advised to make periodic checks of the area as well.

On March 26, 2022, the Homer Elks Lodge had their 9th annual March Madness 3k walk / run. Approximately 75 people participated in this event, and we assisted with traffic with no issues.

Also on March 26, 2022, was the 2022 Polar Plunge "Freezin' for a Reason" Special Olympics fundraiser at Taughannonck Falls State Park. Officer Howell, Recruit Office Cowan and I, along with other area law enforcement and other organizations, took a plunge into the frigid Cayuga Lake. Over 700 people participated in this event and over \$85,000 was raised for Special Olympics New York.

In conclusion, the annual Active Shooter in-service training will be on April 2, 2022, at the Homer Elementary School. Unlike the past years, this training will be for only officers with this agency. Along with active shooter training, officers will receive first aid, CPR, automated external defibrillator (AED) and Narcan training. Legal updates will also be reviewed during their working lunch.

- Cleaned all pump stations and floats.
- Check all pump readings each day.
