Mayor and members of the board,

### **Patrol Monthly Activities:**

Please refer to the attached detailed reports for last month. There were a total of 531 calls for service during the month of April. Officers made 2 unclassified misdemeanor arrests for aggravated unlicensed operation of a motor vehicle in the 3<sup>rd</sup> degree, an unclassified misdemeanor arrests for aggravated unlicensed operation of a motor vehicle in the2nd degree, an unclassified misdemeanor arrest for operating a motor vehicle while registration was suspended, a violation arrest and 3 misdemeanor arrests. Officers conducted 71 vehicle and traffic stops and issued 34 traffic tickets. They also responded to 8 motor vehicle collisions, 1 of which involved personal injury.

Notable investigations or incidents during the month of April: a criminal mischief to a motor vehicle investigation; a criminal mischief to a door window that resulted in an arrest; a disorderly subject who was obstructing traffic and was arrested; a grand larceny involving currency being stolen from a business and two separate fraud investigations where accounts were compromised.

### **School Officers Reports:**

Please refer to the attached detailed school resource officer's report for the month of April 2024. There were a total of 544 incidents that the resource officers were involved in during the month of April.

### Recent updates:

Security cameras updates: there are no issues with the cameras.

Patrol vehicle updates: Dovi Motors received the rear axle bolt for patrol vehicle 225, which was on recall. Patrol vehicle 125 is also affected. Appointments have been made for 225 to go to Dovi Motors on May 7<sup>th</sup> and 125 on May 14<sup>th</sup>. On April 18, 2024, the 2024 Ram pickup truck to replace patrol vehicle 126, was delivered by Robert Green Auto and Truck Inc. The truck was taken to O'Graphic's Design for decaling and is currently at Priority Fire for equipment installation. As indicated in last month's report, the Dodge Charger that replaced patrol vehicle 226 is in-service but it was not equipped with a new dash-cameras because we had not received them but we since have. The cameras will be installed in the patrol vehicles starting with patrol vehicle 126, followed and they will be patrol vehicle 226 and then 225. Also, the new rifle mount for 226 was received and was installed by Priority Fire.

Grant updates: there are some statewide traffic safety enforcement campaigns in May (click it or ticket) that we will be utilizing the grant funding from the 2024 New York State traffic safety grant. I once again applied for a traffic safety grant for 2025 through the Governor's Traffic Safety. I will receive a notification sometime over the next few months on the funding we are awarded.

As of the date of this report, I have not received a notification from New York State Division of Criminal Justice Services (DCJS) regarding the Law Enforcement Technologies (LETECH) and Applicable Software /Equipment Grant that I applied for.

I have also not received any notifications for the body warn camera grant through the Small, Rural, and Tribal Body-Worn Camera Grant Program through the Bureau of Justice Assistance of the Office of Justice Programs, U.S. Department of Justice & Security Strategies that I applied for.

As indicated in last month's report, we are utilizing TenKate Grant Services to apply for the US Department of Justice COPS Hiring Program grant and Preparing for Active Shooter Situations grant. I have been in communication with them, and it was recently determined that the active shooter grant is closed, but we will be applying for the hiring grant.

Regarding the body warn cameras, we are working with the assistance of the village information technology department, Plan First and the manufacturer of the cameras, Motorola, so that we can meet our tentative date of June 25, 2024, for officers to begin wearing the body warn cameras. We are also updating our departmental policy regarding them, and officers will receive training in the use prior to the June date.

The Patrick Leahy Bulletproof Vest Partnership (BVP) Program, administered by the Bureau of Justice Assistance (BJA), grant program is open until Monday, June 10, 2024. The grant up to 50 percent of the cost of body armor vests purchased for law enforcement officers. We have applied for and received this grant before in the past and I will be applying for it again this year.

### Miscellaneous and Events:

Last month county wide law enforcement met with the Cortland County Emergency Response and Communications director, who oversees the 911 center, and we discussed issues or concerns. One item that we discussed was a monthly test of the emergency activation buttons on officer's portable radios and patrol vehicle radios. We were the first agency in the county to conduct the test. We had no issues but determined that the emergency button on the external mics of the portable radios does not work and officers were made aware of this.

Sgt Soderholm completed the supervisors training at Solvay Police Department on April 2, 2024. The training is a NYS Department of Criminal Justice Services course and is mandatory for all new supervisors within their first year of appointment.

The historical lunar eclipse occurred during the afternoon of April 8, 2024. After the eclipse, traffic state routes became an issue in the village. As indicated in last months report, I scheduled two extra officers to work from 3pm-7pm to help alleviate any traffic issues, which they did. Members of the Homer Fire Department were also very instrumental in assisting us with traffic. Other than a delay in traffic at intersections, there were no motor vehicle accidents in the village.

Last May I attended the FBI's National Command Course (NCC) near Washington DC and became a member of the NCC association. Throughout the year the association hosts continual leadership courses taught by current or retired FBI agents. Between April 10, 2024, and April 12, 2024, I attended an associate sponsored course titled "Excellence in Small Agency Policing" near Pittsburgh, PA. The topics presented during the course consisted of: Creating your Personal Leadership Philosophy; Leading Well; the Emotionally Intelligent Leader; Identity: The Hidden Driver of Leadership; Creating a Culture of Accountability; Crisis Leadership; Difficult Conversations and Class Personal Leadership Philosophies. I believe the course was very beneficial not only towards me, but for the agency based on what I learned.

Amnesty Day was on May 20, 2024. An officer was present and checked or verified addresses of people dropping off refuse and had no issues.

The Cortland County Child Advocacy Center hosted an Arts & Awareness Event at the Center for the Arts of Homer on April 23, 2024. The event was in correlation to Child Abuse Prevention Month as a way to spread community awareness and connect families to the arts. We participated in this event by fingerprinting children.

In conclusion, on April 14th we there was a tragic loss of two police officers from the Central New York Area, Syracuse Police Officer Jensen and Onondaga County Sheriff's Lieutenant Hoosock. Although these officers did not work within this county, officers with our agency knew the officers that were killed in the line of duty, and we proudly attended their funerals as representatives from the Village of Homer.
