July 2024 Monthly report

Date: July 26, 2024

Mayor and members of the board,

Patrol Monthly Activities:

Please refer to the attached detailed reports for last month. There were a total of 506 calls for service during the month of July. Officers made 6 misdemeanors arrests, 3 felony arrests, 3 unclassified misdemeanor arrests for aggravated unlicensed operation of a motor vehicle in the 3rd degree and 1 unclassified misdemeanor arrest for reckless driving. Officers conducted 76 vehicle and traffic stops and issued 46 traffic tickets. They also responded to 7 motor vehicle collisions, 2 of which involved personal injury.

Notable investigations or incidents during the month of July: criminal mischief to 2 motor vehicles; multiple larcenies from unlocked motor vehicles which resulted in an arrest; a motor vehicle collision involving a motorcycle and motor vehicle; a fraud involving a computer; a motor vehicle collision where a driver suffered a medical condition and struck another vehicle, telephone and the steps of a residence and a larceny from a local business

School Officers Reports:

No School Resource Officer Report due to student summer vacation.

Recent updates:

Security cameras updates: there are no issues with the cameras. However, through the NYS Technology Grant I am looking at possibly adding more security cameras to village buildings or parks.

Patrol vehicle updates: Patrol vehicle 125 has a recall for the rear axle bolt and we are still waiting on the part from Dovi Motors. As noted in last month's report, the air conditioning unit in 125 is not working and it when the rear axle bolt is replaced we have Dovi Motors repair it as well. This vehicle is utilized by the SRO's and is not used for regular patrol, just events, during the summer months. The new dashcams have been installed in all the patrol vehicles. Unmarked vehicle 250, the 2021 Chevrolet Trailblazer had an issue with the E-vap system and it needed to be replaced. It was taken to Royal Motors on July 18, 2024, and it was repaired without incident, under warranty.

Grant updates: I have not received any notifications regarding the 2025 Traffic Safety Grant that I applied for in May. However, Stop DWI funding was utilized for DWI patrol over Independence Day weekend.

Also, as of this date, I have also not received any notifications regarding the body warn camera grant through the Small, Rural, and Tribal Body-Worn Camera Grant Program through the Bureau of Justice Assistance of the Office of Justice Programs, U.S. Department of Justice and Justice & Security Strategies.

The New York State Division of Criminal Justice Services (DCJS) Law Enforcement Technologies (LETECH) and Applicable Software /Equipment Grant, the fundings were released by the state and deposited in the SFS account listed on our application. I have since placed orders for new laptop computers and printers for the patrol vehicles, license plate readers and additional body warn cameras. I have been contact with vendors about purchasing drones, street cameras (license plate readers) and portable radios.

Regarding the new body worn cameras, although we had a tentative date of June 25, 2024, for officers to begin wearing the cameras, he delayed issuing them until the officers received the in person training from Motorola, which is scheduled for July 24, 2024, and July 25, 2024. Once the officers receive the training and our policy is updated they will begin wearing the cameras.

Miscellaneous and Events:

Homer High School graduation was on June 29, 2024. The commencement ceremony was supposed to occur at Butts Field (football stadium) but due to the inclement weather it was held inside in the auditorium. School resource officers were present for security and safety purposes and there were no issues.

On July 9, 2024 and July 10, 2024, we hosted an ATF Ghost Gun Training at the Cortland County Regional Training Center. The training was open to several agencies in the Central New York and Southern Tier areas. ATF agents presented information regarding ghost guns, 3-D printers, silencers and legal vs illegal firearms. It was a very informative class.

During the late afternoon hours on July 11, 2024, a severe storm struck various parts of the village and Cortland County. Officer Brewster and I assisted the fire department with removing trees or tree branches from the roadway as well as checked for other possible storm damage around the village.

On July 11, 2024, a Threat Assessment Management Team meeting at the Cortland County Regional Training Center. The team was recently created for the purpose of information sharing involving government and non-government to prevent terrorism and other acts of violence. The sheriff's office organized the team and it was supported by the NYS Department of Homeland Security.

Also on July 11, 2024, the police department was the host department for Recreation's "Movie on the Green". This was a well-attended event. I would like to commend Recreation Director Andrew Pierce for organizing it and inviting us to participate.

The New York State Association of Chief of Police conference was in Buffalo, NY this year between July 14, 2024 and July 17, 2024. I attended the conference and I believe it was very beneficial for not only myself but the information I learned during it to aid in the management of the police department.

Holiday in Homer was on July 2024. We provided security during the event without any issues. We also organized the annual fundraiser, "Dunk a Cop" during it and raised funds for the Cortland County Child Advocacy Center. I would like to thank the First Religious Society, Paula Harrington and Pastor Vickie for allowing us to have this fundraiser during Holiday in Homer. I would also like to thank CNY Rental for donating the dunk booth for this event.

Officer Smiley and Officer Brewster, who are both certified to fly the drone, attended a NYS Public Safety Drone Summit on July 23, 2024 and July 24, 2024 at the NYS Fair Grounds in Syracuse, NY. There was no cost associated to attend this summit, where they were provided information to help with our drone program.

The annual 50-mile Route 90 Sales from Homer to Montezuma was the last full week of July (July 26, 2024 through July 28, 2024). The south shoulder of Cayuga St was again posted with temporary no parking signs to prevent and traffic or parking issues during the sales and so that a fire truck could safely pass through the area. There were no incidents to report.

During the month of July we utilized the drone for Holiday in Homer as the Route 90 Sales. We also utilized the drone for photographs of the storm damage that occurred on July 10, 2024. There was also a request by the New York State Police for the drone for a wanted subject who fled on foot into the woods in the area of Polkville. The subject was not located and the search was terminated.

In conclusion, there are events in August that I have been assisting with organizing, National Night Out on August 6, 2024, the Brockway Parade and Truck Show on August 10, 2024, and Magic on Main on August 16, 2024. With these events I have submitted to New York State Department of Transportation (DOT) Application for Special Use applications to close North/South Main Street. Along with the permits, action plans, detour maps and road closure maps were also submitted. We have submitted these permits for these events over the past years and I don't believe there will be any issues with us receiving them.
